# How will Health Care Reform Impact You?

This past March, the Health Care Reform bill was signed by the President. Championed by disability rights activists, the new law will afford people with disabilities greater access to quality health care.

Following are a few provisions that will benefit you as an American with a disability:

- Health insurers will no longer be able to deny coverage due to disabilities or other pre-existing conditions
- Lifetime and annual caps on benefits will be prohibited
- Medicaid will be expanded to provide coverage to non-elderly, childless adults with incomes up to 133% of the Federal Poverty Level
- Most Insurance plans will be required to cover rehabilitative and habilitative services and devices
- The Community First Choice Option encourages state Medicaid plans to choose home and communitybased services first over institutional settings
- Money Follows the Person will be extended until 2016, providing funds for the relocation of Medicaid Beneficiaries from institutions to community settings

### It's Our Story: National Media and History Project

It's Our Story is an online database of personal testimonials and oral histories provided by individuals with disabilities over the last several decades.

The collection of testimonials, known as the "Discrimination Diaries", was started in the 1980s by Justin Dart Jr., a disability advocate who played a pivotal role in the passage of the landmark Americans with Disabilities Act. After Mr. Dart's passing, a gentleman named Scott Cooper continued this journey with a video camera, capturing "oral histories" from more than one thousand disability advocates in more than 100 cities across the United States.

Now, these diaries and oral histories will be brought together in a database that will serve as our nation's single most significant collection of primary source records of the disability experience.
